

## Elentra Daily Clinical Encounter Tracking Tool Queen's PT Program



#### **Introduction to Elentra:**



Queen's PT has been working with Elentra to develop an online tracking system to capture information about student progress while accumulating clinical experiences.

Elentra is a Queen's lead initiative that provides health sciences institutions with the complete platform to deliver and track their curriculum.



## Why are we tracking experiences?:



#### **Clinical Education Guidelines**

• All accredited PT Programs in Canada require students to have involvement with a mix of clinical caseloads.

#### The minimum requirements include:

Accumulating 100 hours or more of:

- cardio-respiratory clinical experience
- neurological clinical experience
- musculoskeletal clinical experience
- Accumulating a minimum of 1025 hours of clinical placement experience
- Breadth of experience in a variety of settings (acute care, rehab, long-term care, community/ambulatory)
- Working with clients with complex medical conditions and across the lifespan





## Will this add time to my day?



- Yes (but not much).
- We anticipate it will take 2-5 minutes to review and approve each day.

#### **Timelines**



• As of January 1, 2020, all placements will utilizing the Elentra Daily Clinical Encounter Tracking Tool.

## **Recording Experiences**



- Hours recorded for the day should capture **ALL** of the student's time.
  - All patient related activities should be captured under the patient encounter:
    - Charting
    - Team meetings
    - Treatment planning time

For non-clinical/patient care activities, student uses N/A option as the primary condition (e.g., cleaning a treatment area, scheduling and organizing their day, meeting with CI, etc.)

- Students use the <u>primary diagnosis</u> as the starting point when considering how many minutes of each area of practice to capture, but also include comorbidities.
- If a particular condition/treatment approach/outcome measure is not present in the list, the student will capture it as <u>"OTHER"</u>.


#### **FAQs**



- What happens if I miss approving one day?
  - The next link you receive will have all pending approvals available for viewing by date.
- What happens if there are two supervisors?
  - The student will direct the approvals to the appropriate supervisor. You will only receive the approvals for the activities under your supervision.
- What happens if my student shadows someone else?
  - That time should be captured and the student will send the approval to you.
- What if I disagree with what the student entered?
  - You have the option to overwrite and then approve or decline and an email will be sent to the student to resubmit.
- Does the student need to see every condition, assessment and treatment approach listed in the drop down menus?
  - No! This would not be possible. We are looking for breadth of experience over the 5 placements.


